AGREEMENT FOR VOLUNTEER SERVICES No.

Concluded on the (Day/Month/Year), in Wólka Okrąglik, between: the Treblinka Museum. The Nazi German Extermination Camp and the Labour Camp (1941-1944), Wólka Okrąglik 115, 08-330 Kosów Lacki, Tax Identification Number (NIP): 8231663667, represented by Dr. Edward Kopówka, Director of the Treblinka Museum,

hereinafter referred to as "the Museum"

and

(full name, residential address, PESEL number)

*represented by (full name of legal representative/guardian, residential address, PESEL number) (*if the volunteer is a minor),

hereinafter referred to as "the Volunteer."

§1

In accordance with the individual arrangements between the Museum and the Volunteer, the Museum entrusts the Volunteer with, and the Volunteer voluntarily agrees to perform, the following tasks for the Museum:

§2

The agreement is concluded for a fixed term, from to

§3

1. The parties to the Agreement agree that the tasks outlined in §1 will be performed under the supervision of a volunteer coordinator or other Museum staff designated by the Volunteer Coordinator. 2. The tasks will be performed at the Treblinka Museum premises and other locations designated by the Volunteer Coordinator.

§4

Given the nature and spirit of volunteering:

- 1. The Volunteer is obligated to personally carry out the agreed tasks.
- 2. The Volunteer will not receive any remuneration for their tasks.

§5

The Museum is obligated to insure the Volunteer against accidents if the agreement is for a period of less than 30 days. If the agreement is for a period longer than 30 days, the insurance costs will be covered by the State Treasury.

§6

The Museum is obligated to provide the Volunteer with safe and hygienic conditions for carrying out their tasks. Depending on the nature of the tasks and associated risks, the Museum also commits to providing the Volunteer with appropriate personal protective equipment.

§7

In accordance with Article 45, Section 4 of the Public Benefit and Volunteer Work Act of April 24, 2003 (consolidated text, Journal of Laws 2023, item 571), the Volunteer fully waives the reimbursement of expenses related to travel to and from the site where their volunteer services are performed.

§8

- 1. The Agreement may be terminated by either party with one week's notice, particularly in cases of violation of any provisions of this agreement or the volunteering regulations.
- 2. Any amendments to the Agreement must be made in writing to be valid.

§9

- 1. The Volunteer declares that they have read and understood the Volunteering Regulations at the Treblinka Museum, German Nazi extermination and labor camp (1941-1944).
- 2. The Volunteer agrees to keep confidential all information obtained while performing tasks for the Museum that constitutes the Museum's confidential information.

- 3. The Volunteer is bound by the confidentiality obligations during the term of the Agreement and after its termination, except for information that must be disclosed by law. The confidentiality obligation does not apply to information available from public sources or information previously known to the Volunteer.
- 4. All documents, plans, data, and other information, along with their carriers, provided to the Volunteer by the Museum in connection with the performance of the Agreement, remain the property of the Museum. Upon termination or expiration of the Agreement, the Volunteer is obligated to return them.
- 5. The parties shall be liable for damages in accordance with the provisions of the Civil Code.
- 6. The Volunteer, their legal representative, or legal guardian may request, within 2 years of the expiration of the Agreement, that the Museum issue a written certificate confirming the completion of the Volunteer's tasks. At the Volunteer's request, this certificate will include details of the tasks performed.

§10

In matters not regulated by the Public Benefit and Volunteer Work Act or this Agreement, the provisions of the Civil Code shall apply.

§11

Any disputes arising from this Agreement shall be resolved by the common court with jurisdiction over the Museum's registered office.

§12

- 1. The Agreement is drawn up in two identical copies, one for each party.
- 2. An attachment to the Agreement is the GDPR clause signed by the Volunteer or the legal representative/guardian of the minor Volunteer.
